### Terms and Conditions.

Our aim is to create for you a safe learning environment combined with fun and enjoyment. However if you have reason to believe that this was not achieved then we ask you to tell your course instructor at the earliest opportunity.

If he is not able to satisfy you then the matter should be taken up with The Principal as soon as is possible.

Malta Sailing Academy has a complaints policy setting out our commitments to solving any problems.

Course refunds will be made at the discretion of The Principal in line with the following policy.

- A place on any course will only be confirmed when full payment has been made.
- A full refund will be given within 7 days of confirmation. This will not apply if confirmation was within one month of the commencement of the course.
- A 50% refund will be given in the event of student cancellation two months prior to the course date
- A 25% refund will be given in the event of student cancellation one month prior to the course date.
- No refunds will normally be given within one month of the course or if a student fails to appear on the day the course .
- Should the course be cancelled because of adverse weather or “majeure” we will not issue any refunds but will guarantee to rearrange the course at a later date.
- If we cancel the course up to two months prior to the course date we will provide a full refund.
- If we have to cancel the course for circumstances other than adverse weather or “majeure” within one month of the commencement of the course we will provide a refund of 85% of the total course fee.
- In the case of overseas students should we have to cancel your course for any unforeseen circumstances after your arrival in Malta then we will only refund the full cost of the course.
